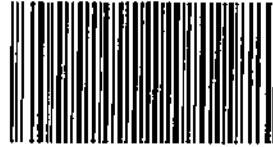

MEMORANDUM OF AMENDMENT

MARINA COAST WATER DISTRICT, a political subdivision of the State of California ("MCWD"), and the J.G. ARMSTRONG FAMILY MEMBERS, the owners of the Armstrong Ranch in the Marina area of Monterey County ("ARMSTRONG"), record this MEMORANDUM to give notice of the following:

1. This MEMORANDUM concerns the real property known as the Armstrong Ranch described in Exhibit C to the "Annexation Agreement and Groundwater Mitigation Framework for Marina Area Lands," recorded August 7, 1996 in the Office of the Monterey County Recorder at Reel 3404 Page 749("Annexation Agreement").

2. MCWD and ARMSTRONG have entered into a written agreement (the "Amendment") modifying their rights as between each other under the Annexation Agreement.

3. The Amendment modifies and extends to June 30, 2010, MCWD's contractual right to purchase a portion of the Armstrong Ranch and certain easements. Reference is made to the Amendment and the Annexation Agreement for terms defining the respective rights and obligations of the parties.

4. This Memorandum of Amendment may be executed in counterparts, each*
